MOTION:

Granum CRC Council motions Classis ABSS, with the concurrence of synodical deputies, to grant permission for Granum CRC to loan Rev. Leon Johnston to Bethel Evangelical Lutheran Church of Frontier, SK under Article 13-c and Supplement, Article 13-c of the CRCNA Church Order.

GROUND:

Upon examining the circumstances concerning Bethel Evangelical Lutheran Church in Frontier SK, Granum CRC Council has determined there is substantial need to loan Rev. Leon Johnston to them. Bethel ELC has been vacant for approximately four years, and they have expressed willingness to have a doctrinally Reformed minister pastor them.

Granum CRC, Rev. Johnston, and Bethel ELC recognize that the loaning will be for a period of two years, as per Article 13-c. After two years, if Bethel ELC has not yet decided to formally join the CRCNA and Rev. Johnston seeks to continue to pastor at Bethel, an extension of the loaning may be requested by Granum CRC.

If the request to extend the loaning is denied by ABSS and/or synodical deputies, Rev. Johnston will determine whether he will end his time at Bethel ELC and seek a call to a CRCNA congregation or leave the CRCNA under Article 14 and continue to pastor at Bethel ELC.

To authorize Jimmy Jo, an elder in Bethel CRC, Saskatoon, to Administer the Sacraments of Baptism and the Lord's Supper per Church Order Article 55

Article 55: The sacraments shall be administered upon the authority of the consistory in the public worship service by a minister of the Word, a commissioned pastor, or, in the case of need, an ordained person who has received the approval of classis, with the use of the prescribed forms or adaptations of them that conform to synodical guidelines. —Cf. Supplement, Article 55 Supplement, Article 55 a. Classis approval is required for an ordained person to administer the sacraments. b. Ordinarily the ordained person should be an elder. (Acts of Synod 2002, p. 537)

2024 TRAVEL POLICY

When travel is required for Classis business, the onus is on the individual to make a cost effective and practical choice when considering transportation.

The following options are available;

1. **Personal Vehicle:** With shorter trips, using your own vehicle is generally the best option. Classis pays mileage as established annually by the CRA. 2024 rates are \$0.70/km for the first 5000 km and \$0.64/km thereafter. (Rates are reviewed annually)
2. **Carpooling:** When possible and as with your personal vehicle, carpooling is often a logical, convenient and cost effective option. CRA rate apply
3. **Car Rental:** On longer trips (over 300km return) a car rental is best. Some rental firms will drop the vehicle at your home or pick you up. Review your insurance for proper coverage.
4. **Bus Charter:** At times the Classis will arrange for a bus charter to accommodate a larger number of travelers. When a charter is made available, the Classis will only pay mileage to and from the point of bus origin or stopover. Again the carpooling guideline applies.
5. **Air Travel:** When distances are excessive, such as for our churches in Saskatchewan, air travel is both a time saver with an often reasonable costs when considering the distance.

1. Tipping: Try to keep "meal tipping" reasonable at around 15%

Covenant for Officebearers in the CRCNA

We, [the undersigned], believe the Holy Scriptures of the Old and New Testaments to be the inspired Word of God, which proclaims the good news of God's creation and redemption through Jesus Christ. Acknowledging the authority of God's Word, we submit to it in all matters of life and faith.

We affirm three creeds—the Apostles' Creed, the Nicene Creed, and the Athanasian Creed—as ecumenical expressions of the Christian faith. In doing so, we confess our faith in unity with followers of Jesus Christ throughout all ages and among all nations.

We also affirm three confessions—the [Belgic Confession](#), the [Heidelberg Catechism](#), and the [Canons of Dort](#)—as historic Reformed expressions of the Christian faith, whose doctrines fully agree with the Word of God. These confessions continue to define the way we understand Scripture, direct the way we live in response to the gospel, and locate us within the larger body of Christ.

Grateful for these expressions of faith, we promise to be formed and governed by them. We heartily believe and will promote and defend their doctrines faithfully, conforming our preaching, teaching, writing, serving, and living to them.

Along with these historic creeds and confessions, we also recognize the witness of *Our World Belongs to God: A Contemporary Testimony* as a current Reformed expression of the Christian faith that forms and guides us in our present context.

We also promise to present or receive confessional difficulties in a spirit of love and fellowship with our brothers and sisters as together we seek a fuller understanding of the gospel. Should we come to believe that a teaching in the confessional documents is not the teaching of God's Word, we will communicate our views to the church, according to the procedures prescribed by the Church Order and its supplements. If the church asks, we will give a full explanation of our views. Further, we promise to submit to the church's judgment and authority.

We honor this covenant for the well-being of the church to the glory of God the Father, Son, and Holy Spirit.

An overture to Classis Alberta South and Saskatchewan

I. Introduction

Following the spring Classis meeting hosted by Emmanuel Christian Reformed Church, our delegates returned feeling discouraged and disheartened by the tone of communication and deliberation. From our perspective, the process was derailed through unhealthy communication and Classis wasted both its time and resources. From what our delegates shared with our Council, we can imagine that they were not alone in how they experienced the last meeting of Classis. At Living Hope Church, we are concerned about Classis and our shared ministry together. The way that Classis has been operating is harming our reputation within the denomination, our witness to the gospel, and our relationships with ministries and organizations outside the church. In addition, the relationships within congregations and among congregations in Classis have become increasingly strained. Classis is in desperate need of leadership that will guide us toward a healthier classical and ecclesial fellowship that is aligned with the decisions of Synod. In response to this, we submit the following overture.

II. Overture

1. That Classis take tangible steps to align itself with the decisions of Synod, especially in light of the decisions made at Synod 2024. Those steps include: (1) That we cease debate on the theological conclusions that are contained within the Human Sexuality Report, and (2) that we provide care and guidance to congregations, officebearers, and members that continue to grapple with synodical decisions.

Grounds:

- i. In 2022, Synod voted in favor of accepting the Human Sexuality report as it provides Biblical teaching on the subject of human sexuality.¹ In addition, Synod voted in favor of clarifying what is encompassed in the word *unchastity* in Heidelberg Catechism Q&A 108.² Finally, Synod voted in favor of instructing Neland Avenue CRC to rescind its decision to ordain a Deacon in a same-sex marriage, nullifying that Deacon's term.³
- ii. In 2023, Synod voted in favor of upholding the Christian Reformed Church's position on marriage to be a confessional doctrine.⁴ Synod also voted against overtures that sought to delay the implementation of the Human Sexuality Report, recognizing the need for implementation and pastoral care for those in opposition.⁵ Synod voted against sustaining Neland Ave CRC's appeal and in doing so upheld the Denomination's biblical and theological

teaching regarding human sexuality.⁶ Synod voted in favor of instructing all classes to guide into compliance officebearers and churches who are in opposition to the biblical guidelines affirmed by Synod 2022 regarding same-sex relationships.⁷

- iii. At Synod 2024, Synod clarified the use of Confessional Difficulty Gravamen and declared that signing a gravamen is not an exception to submission to the teaching of the Reformed Confessions.⁸ Furthermore, Synod declared that signing a gravamen does not permit an officebearer to hold an unresolved difficulty but must work to resolve that difficulty.⁹ Regarding officebearers in protest, Synod decided to place those officebearers on a limited suspension in order to guide them into compliance.¹⁰ If neither restoration nor disaffiliation occurs during the limited suspension, Synod has tasked each Classis to remove the Council of that church and place them in emergent church status under the authority of a neighboring Council.¹¹ In order to ensure faithfulness to the Reformed Confessions, Synod declared that officebearers will be required to sign the covenant for officebearers each year.¹²
- iv. The Denomination has mechanisms in place that exist to provide care and support to members of local congregations, Councils, and Officebearers. Those mechanisms include Thrive ministries, Regional pastors, and church visitors, to name a few.

- 2. That Classis take tangible steps to address officebearers and congregations in protest of Synodical decisions. Those steps include: (1) That Classis ensure that those who have signed a gravamen are doing the work to resolve their theological difficulties within the timeframe set by Synod 2024, and (2) that Classis guide congregations toward alignment with the decisions of Synod or toward disaffiliation with the denomination.

Grounds:

- i. At Synod 2024, Article 5 was discussed and the purpose for using confessional-difficulty gravamen was adopted.¹³ The purpose includes helping congregations to understand the process, preventing the misuse of a gravamen, and restoring officebearers to doctrinal unity, among others.
- ii. As per Synod 2024, officebearers that have signed a gravamen have three years to work out their theological difficulty.¹⁴
- iii. As per Synod 2024, congregations have been instructed to either align with the decisions of Synod or begin the process of disaffiliation, as per Church Order Article 38-f.¹⁵

III. Conclusion

As the Human Sexuality Report suggests, our failure to be salt and light has compromised our witness to the gospel. Yet, we have a historic opportunity to reexamine ourselves and our communities, confess the sins that we have committed against each other, and to walk alongside each other on the costly path of loving discipleship.¹⁶ At Living Hope Church, we desire to work alongside Classis to improve our communication, discernment, and deliberation, and we desire to restore unity within Classis for the sake of our shared ministry.

III. MATTERS LEGALLY BEFORE CLASSIS

The following matters are legally before Classis:

- A. OVERTURES** from Councils. These overtures shall be sent to the Stated Clerk six weeks before Classis convenes, so they can be included in the agenda sent to Councils;
- B. REPORTS** of committees and representatives of classical and denominational boards must be sent to the Stated Clerk, before the agenda deadline, to be included with the agenda. Recommendations from the committees shall be considered at Classis.
- C. MATTERS PRESENTED ON THE CREDENTIALS;**
- D. APPEALS AND PROTESTS** from Councils;
- E. APPEALS AND PROTESTS** from individual members after having been processed through their local Council;
- F. EXCEPTIONS.** Matters not appearing on the Agenda of Classis or in credentials may be taken up by special motion of Classis.

WITH

III. MATTERS LEGALLY BEFORE CLASSIS :

1. Overture, Motions, and Communications.
 - a. All of the above shall be sent to the Stated Clerk six weeks before Classis convenes. The CIC will be responsible to ensure that all items that are presented on the agenda are properly received, written and in good order. All overtures, motions, and Communications will be evaluated by the Overture committee (assigned by the CIC) which will make the recommendation to Classis to accede, adopt or approve.
 - b. Responses taking the form of an overture, motion, or communication from Councils and Committees to items on the classis agenda must be sent to the Stated Clerk at least one week in advance of classis so that they can be evaluated by the appropriate committee before classis convenes. If possible, these responses will be forwarded to delegates as late materials.
2. Matter Presented on the Credentials
 - a. Answers to the questions on the Credentials Form shall be legally before classis.
 - b. Overtures, motions, and communications that arrive at classis via the credentials will be evaluated by the credentials committee to ensure that they are in proper order. The credentials committee will make a recommendation to classis as to whether it will receive these overtures, motions, or communications by way of exception.
 - c. Councils should not expect that matters sent to classis via the credentials will be dealt with at that classis meeting but may be referred to future classis meetings or assigned to an appropriate committee or individual for follow up.

3. Appeals and Protests from Councils
 - a. All appeals and protests directed toward classis shall be sent to the Stated Clerk at least one week in advance of classis and will be read into the minutes at the appropriate time during the classis meeting.
 - b. Appeals and protests which have been directed toward an individual or a council shall be dealt with in the said council before they can be processed at classis. The council against which the protest or appeal has been lodged will be prepared to state when they dealt with the protest or appeal and that they did not accede to it.
4. Exceptions
 - a. Matters not appearing on the Agenda of Classis which have not been received by the required deadline shall be included in the Classis Agenda only by means of a special motion of classis.
5. REPORTS of committees and representatives of classical and denominational boards must be sent to the Stated Clerk, before the agenda deadline, to be included with the agenda. Recommendations from the committees shall be considered at Classis.

Grounds:

1. It is the accepted practice of synod to appoint Advisory Committees to discuss and evaluate and make recommendations regarding all matters that are before synod. Similarly both classis and churches will benefit from the advice of these committees.
 - a. Example: A council sends an overture to classis asking that classis adopt it as its own, but the overture has multiple references to the local church. The Advisory Committee could recommend that classis adopt the motion but change the wording so that it can become the overture of classis. (see Rules for Synodical Procedure, V.B.3.b which contains the language “adopt as its own” with regard to overtures.)
 - b. Example: A council sends a motion asking that classis address an issue that has risen in its own community. The advisory committee returns the motion to the church indicating that because it is a local issue, classis has no authority to address it. (See Church Order, Article 28b which states, “A major assembly shall deal only with those matters which concern its churches in common . . .”)
 - c. A church sends a motion to classis via its credentials. If the credentials committee deems that the motion is in good order, it would ask classis to vote that it be included, by way of exception, in the agenda of that meeting.
2. Delegates need time to reflect on the matters on which they will need to make decisions.
3. Councils, normally, will receive the Classis Agenda five weeks before classis convenes, giving them ample time to respond to the Stated Clerk at least one week before classis convenes.
4. These rules do not prevent councils from submitting late items but do give classis the option to decide if they have a place on the agenda.

**Safe Church Coordinator Report
Classis Southern Alberta/Saskatchewan
October 2024 Classis**

Greetings once again to the churches of Classis Alberta South/Saskatchewan,

During Synod 2024 the Safe Church Ministry celebrated their 30th anniversary. In 1994 the Office of Abuse Prevention was started and in 2009 the ministry was renamed Safe Church. At this time approximately 88% of churches have a safe church policy and 69% of Classis have safe church coordinators.

The theme for the year is “Safe People, Safe Congregations”.

*Safe congregations are places where people can worship God and grow in faith freely without the fear of being hurt, harassed, or harmed. They are made up of safe people who . . .

- treat each person with dignity and respect.
- actively listen with compassion and empathy to others.
- act with honesty and integrity.
- respect others’ boundaries.
- admit and apologize after wronging someone.
- advocate for the marginalized and the vulnerable.

The Code of Conduct was also ratified at Synod. You can find this document and a FAQ via the link here [Code of Conduct for Ministry Leaders | CRC Network \(crcna.org\)](https://cna.org/crcna/crcna-code-of-conduct) . Each church and Classis is asked to review and implement this tool.

I’d like to take this opportunity to highlight the first section of the document as it is a good reminder for us in our interactions with each other.

****Relationships**

1. I will speak and act, in all my personal and professional relations, in ways that follow the pattern of Christ, who used His power to serve (1Peter 5; Mark 10; Phil 2; 2 Timothy 4:2).

2. I will respect, love and treat with integrity and truthfulness people of every position, status, race, ethnicity, gender, age or ability.
3. I will maintain appropriate emotional, physical and sexual boundaries in all relationships.
4. I will keep all my relationships free from inappropriate, unwanted physical contact, emotional or sexual intimacy, sexual comments, gestures or jokes.

Finally, in an effort to have clarity in the role of Classis Safe Church Coordinator I have presented the attached Job Description to the CMC and now to Classis for your approval. This document came about as I learned from other Safe Church Coordinators from across Canada that many of them have job descriptions. This is presented to provide clarity to the role for myself and anyone who takes the role in the future but also as a tool to evaluate the work being done, set parameters and a basis for accountability.

CLASSIS ALBERTA SOUTH/SASKATCHEWAN
SAFE CHURCH COORDINATOR
JOB DESCRIPTION

Purpose:

The purpose for the Safe Church Coordinator (Coordinator) position is to assist classis and its member churches in establishing, reviewing, implementing and monitoring safe church and abuse of power issues.

Reporting:

The Coordinator reports to the CIC (CMC) as required and provides a written summary report to full classis at the Spring and Fall meetings.

Appointment:

The Coordinator must be a confessing member of a church of classis, appointed by the classis for a 3 year term with eligibility for additional 3 year terms.

Tasks/responsibilities:

- Education: The Coordinator, upon request of local church councils or it's designated committee, will provide training, resources and workshops on various topics related to Safe Church Ministry and assist then in establishing and implementing safe church policies that are approved by their insurance provider, in accordance with its abuse and harassment coverage certificate. The form and scope of assistance will take into account each church's particular ministry context. This personalized assistance can include the determination of who must obtain a police check and how that can be done most efficiently.
- Support: The Coordinator, upon request of a local church or it's designated committee will provide advice and consultation to ministry leaders. The Coordinator will field inquiries from individuals and churches relating to abuse and response in a church.
- Advisory Panel: The Coordinator, upon request of a local church council or it's designated committee, will, in conjunction with the CRCNA's Safe Church Ministry, gather and conduct a panel process for the protection of vulnerable persons vis-à-vis council member or other ministry leader where a power imbalance exists, as needed.
- Monitoring: Within the provisions of Church Order, Article 42, classis assigns the Coordinator to visit the council, or designated committee, of each church in classis on a yearly basis to evaluate the safe church policies and practices relating to safe church and abuse of power.
- Insurance Verification: The Coordinator will seek to obtain a copy of the abuse and harassment insurance certificate from each church and send it to the stated clerk of classis so that classis may be able to obtain its own insurance.
- Abuse and Harassment Policy for Classis: The Coordinator will develop and monitor the abuse and harassment policies for classis itself, including any policies required for a campus ministry.
- Collaboration: The Coordinator will collaborate and work with the Safe Church office of the CRCNA via attendance at regular safe church coordinator meetings and attend other training and education opportunities when possible.

Calgary Campus Ministry Committee Report for Classis ABSS's October 2024 Agenda

As you will see below, we are bringing forward:

1. A request that Paul Verhoef verbally address classis about the Campus Ministry transition.
2. A motion regarding \$16,000, the net surplus funds remaining from eight years of previous Campus Ministry budget and expenses.

Overview of the Calgary Campus Ministry Transition

In 1999, our Classis Alberta South & Saskatchewan (Classis ABSS) tasked a team to visit the University of Calgary and to discern if another Christian campus ministry would be feasible, a new ministry with Reformed theological rooting. That team came back to Classis ABSS and asked, “Do you love the University of Calgary enough to invest in it by creating a new Reformed campus ministry?” The churches said, “Yes,” and started searching for a campus minister to be sent to the university as a faithful presence of God’s love. Paul Verhoef was that initial campus minister.

Paul started full-time in 2004, and was later joined by other part-time Christian Reformed campus ministers (Pearl Nieuwenhuis, Jacqui Mignault, Layne Kilbreath). With thanks to God, the campus ministry made many connections with students and staff, catalyzed communities, and much more. In summary, for two decades, the Calgary Campus Ministers, as sent officially by Classis ABSS, were faithful presences of God’s love to the University of Calgary (and adding Mount Royal University as well).

This Calgary Campus Ministry **continues** – with the **same mission, same vision, and the same people**. This Calgary Campus Ministry will continue to “educate and witness to the reign of Jesus Christ” (the opening sentence from Paul’s 2004 job description) because these Campus Ministers still feel “called to be a public witness to and an embodiment of the love of Jesus Christ in the world of the academy” (the opening sentence from the new 2025 job description). The Calgary Campus Ministry is excited to continue to be a campus ministry rooted in a Reformed theological imagination, bearing witness to how God is reconciling all things to himself through Jesus.

What is **changing** is that the Calgary Campus Ministry will no longer be a ministry of Classis ABSS in 2025 and beyond. In order to make both the ministry and the classis sustainable, the ministry will now be operated outside of our classis by an organization called the Calgary Campus Ministry Society.

Our Concluding Work as the Calgary Campus Ministry Committee of Classis ABSS

In October 2023, our committee was tasked with “enabling the closing” of the Calgary Campus Ministry as a ministry of our classis. As a committee, we are delighted that the Calgary Campus Ministry will **continue**.

With this in mind, we would make a **request**:

Request: The Calgary Campus Ministry Committee requests that Paul Verhoef be give 10 minutes to verbally address classis at the October 2024 meeting to share about the Campus Ministry transition.

We are also thankful that Classis ABSS committed to a classical contribution of \$141,736 for 2024 to equip the transition. As we have stewarded this closing as a ministry of classis, we have asked a few questions that lead us to the following motion. We propose the following motion for classis to consider.

Background to Motion

Already starting in 2004, the Calgary Campus Ministry budget was never fully supplied by the ministry shares of Classis ABSS. Rather, throughout the last 20 years, the income has also come from other sources specifically designated for the Calgary Campus Ministry: Resonate grants, individual donors, financial support from churches outside of ABSS and additional offerings from churches within ABSS. In following up on a request, Classical Treasurer Peter VandenDool determined that from 2016-2023, the Calgary Campus Ministry has a net surplus of \$16,000. That is, when one compares the budget (including both classical shares and external funds raised) to the expenses over the last eight years, the Calgary Campus Ministry has a net \$16,000 surplus.

We want to recognize that Classis ABSS has the full right to determine the direction and control of those funds. And if the Calgary Campus Ministry was not continuing, we would certainly not make this motion. But, given that these \$16,000 are a result of a net surplus over the last eight years AND given that the Calgary Campus Ministry is continuing, it seemed reasonable to our committee to put forward the following motion for the consideration of Classis ABSS:

Motion: That this \$16,000 Calgary Campus Ministry net surplus from 2016-2023 be designated by Classis ABSS for the work of the Calgary Campus Ministry over-and-above the classical ministry share requested portion of \$141,736 for 2024, and that whatever portion of this \$16,000 is required to supplement the 2024 Calgary Campus Ministry expenses would be used in 2024. After the final expenses for Calgary Campus Ministry in 2024 have been reimbursed, any remaining portion of that \$16,000 would then be directed before the end of the 2024 by the Calgary Campus Ministry Committee to the appropriate organization governing the continued work of the Calgary Campus Ministry for their use in 2025.

Grounds:

1. In October 2023, Classis ABSS committed to supporting the Calgary Campus Ministry with \$141,736 and this amount was included in the Classical Ministry Shares for ABSS. This motion does not request any additional ministry shares to be collected from the churches of Classis ABSS.
2. The \$16,000 noted in this motion is the net surplus of money originally intended to support the Calgary Campus Ministry and it is reasonable to continue to direct these donations toward this same purpose, as this motion makes possible.

As the Calgary Campus Ministry Committee, we are grateful to be a part of the good work God did through this classical ministry, and we pray God continues to bless this good work.

His last day was September 20. Pastor Lesli Van Milligen will take over as director of Thrive.

Chris writes, “I am thankful for the opportunities I have had to serve within the CRCNA ministries over the past five years. Through my time here, I have been able to experience and witness more of God’s goodness and faithfulness through so many people and circumstances that I otherwise would not have encountered – and that has been a gift I will bring with me into the next season of life and ministry.” Notable contributions include the intergenerational program [Generation Spark](#), and [Thriving Together](#), a program to assist pastors who are in a place of transition, either in their churches or in their overall life and ministry.

Please pray for the work of Thrive and all the ministries which they oversee, for Faith Formation as the denomination continues to navigate a difficult climate, for Thrive staff and especially Lesli as she takes on the role of sole director of Thrive. Pray that the spirit will continue to work through Lesli and the Thrive staff as they continue to support churches throughout the denomination. We thank Chris for his rich legacy of leadership in the CRC.

Uncertainty lies ahead for the denomination but our desire to be growing in faith, to be sharing the love of God with our neighbour and around the world, remains strong. 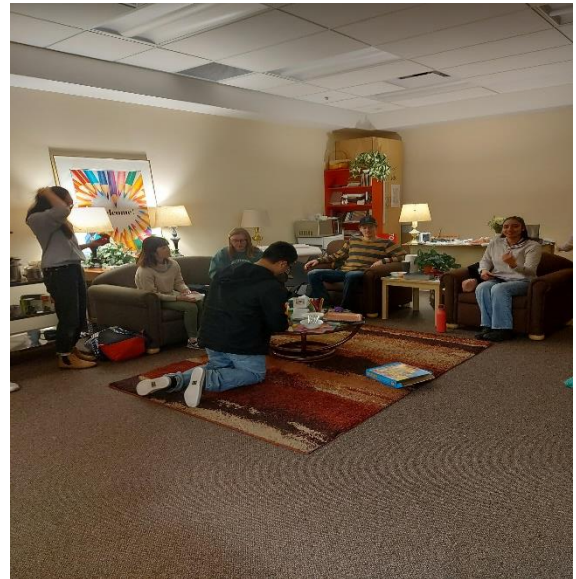


My First Stab at Beading!

scholarship and that he is now a lot less stressed out than he used to be. Her response: "That's Grace-That's God's Grace." I give God praise for the way our believing students bring God's Grace into most every conversation with their unbelieving friends!

A Tale of Four Students They all frequent the Chaplaincy Centre. Two got married to each other in a beautiful Christian wedding. The other two got baptized. When I see Christian Students growing in their faith it reminds me of the Hymn:

"I love to tell the story;
For those who know it best
Seem hungering and thirsting
To hear it like the rest."

What a joy to see students growing in their Faith! Another semester of weekly Bible Study and worship has begun! The first gathering of the semester brought a dozen people together, with both the keyboard and guitar! We are also looking forward to our "Chaplain's Retreat which is scheduled for September 20-22 at Whispering Pines Bible Camp!

You Need to Rent a Bus! Every month YXH (Medicine Hat's Airport Code) Young Adults meets in a different church or at the college. It brings together close to a hundred young adults from across the city together for a time of praise and worship. After a not yet believing student attended YXH Young Adults I invited him to attend the City-Wide Good Friday Service. After the service he said; "Next year you need to rent a bus so all my friends can come!" What a joy it is to introduce those who are not yet believers to Christian Worship!

Report from the Oversight Committee for Maranatha CRC (Calgary)

We are the committee assigned to oversee the readiness of Maranatha CRC (Calgary) to call a new pastor after their Article 17 separation from Rev. Allan Kirkpatrick. As part of our report, we are included a letter (below) from the chair of the council of Maranatha CRC (Calgary) updating us on their process. A couple notes to highlight:

1. At the present time, Maranatha CRC is feeling sufficiently supported by the multiple part-time pastors in this interim period. In addition, they are also finding themselves financially sustainable. We thank God for this good provision.
2. During this interim period, the Council has identified two major goals as they move towards readiness to call a new pastor: first, to continue to build a healthy church with strong internal relationships and, second, to refine their church's vision and mission. Once these first two pieces are further along, they will discern with us their congregational readiness to call a new minister.

As a committee, we recognize that Maranatha CRC is moving slowly through this process – but we are glad that they have engaged wise leaders along the path. We are glad to continue with them at the pace they have discerned, and we will continue to liaise with them on behalf of Classis ABSS.

We invite all of Classis ABSS to join us in our prayers and support for Maranatha CRC (Calgary).

Dear oversight committee,

I hope this message finds you well. I wanted to provide an update on Maranatha CRC and where we currently stand in terms of readiness to call a full-time pastor.

Our congregation remains steady, with around 50-60 attendees each week. We are grateful for the guidance of three pastors who have been helping us through this season:

- Pastor Ed Jager is primarily overseeing preaching, supported by guest pastors when necessary.
- Pastor Heather Cowie leads Tuesday night sessions focused on Spiritual Direction, offering valuable support in that area.
- Rev. Ken Demaere has been coaching our leadership, helping us define who we are as a church and where we need to go. He also fills the pulpit from time to time.

Financially, we've remained stable, thanks to consistent giving and rental income. Being without a full-time pastor has also alleviated some of the financial pressures.

Maranatha has certainly been through a challenging few years, facing what feels like a "Triple Whammy":

1. Divisiveness during COVID-19,
2. Navigating the complexities of an Article 17 with our previous pastor,
3. And working through the recent changes to our confessions based on the denomination's Human Sexuality Report (HSR) and how this might impact our membership.

Despite these challenges, we remain committed to our focus areas:

1. Building a healthy church with strong internal relationships,
2. Refining our vision with the help of Thrive and Rev. Ken,
3. And only then, finding a pastor who aligns with this vision.

At this moment, we are still in the process of focusing on “who we are” as a congregation. Our leadership is working on defining our direction this fall, and once this becomes clear, we will have a better understanding of what we need from a pastor.

For now, our "Fractional Pastor Plan"—with Heather, Ed, and Ken sharing responsibilities—has been serving us well. This approach is allowing us to focus on internal health and clarity before moving forward with a pastoral search.

We appreciate your continued prayers and support as we move through this period of reflection and discernment. We look forward to sharing more as we define our future path.

COD Highlights

A SUMMARY OF THE COUNCIL OF DELEGATES MEETING

To: **CRC Councils and Stated Clerks of Classes**

Date: May 9, 2024

Highlights from meeting of May 1-3, 2024

The Council of Delegates (COD) of the Christian Reformed Church in North America met at Cascade Fellowship Christian Reformed Church in Grand Rapids, Mich. on May 1-3, 2024. During this meeting, the COD spent time in prayer, received reports, held discussions, and made decisions as follows:

- Celebrated outgoing COD members and thanked them for their service.
- Spent time in prayer for the family of Rev. Scott DeVries, former director of synodical services, who passed away on Apr. 27.
- Approved Rev. Joel Vande Werken as the temporary associate director of synodical services through Aug. 31 to support Synod 2024. The general secretary will review the job description and begin a search process for a new, permanent replacement in the future.
- Approved several motions related to the sale of the Grand Rapids denominational office building at 1700 28th Street SE and regarding the purchase of property at 300 East Beltline NE in Grand Rapids as the new ministry support center location.
- Instructed *The Banner* to become self-sustaining through revenue and fundraising, not including ministry shares, beginning in fiscal year 2027. To achieve this goal, *The Banner* will be asked to reduce its reliance on ministry share contributions over the next three years.
- Heard about the first *Gather* event, which took place in Minneapolis, Minn. Additional events are planned for fall 2024 and winter 2025. Each event will bring together five classes at a time to help address membership decline in our churches in response to a directive from Synod 2023. More information is available at crcna.org/Gather.
- Adopted a revised report from the Global Vision Team, forwarding it to Synod 2024 for adoption as a guide to classes that are in conversation with congregations outside North America who desire to affiliate with the CRCNA. This includes asking the general secretary to establish a Vision Implementation Team of diverse members from the CRCNA and its international partners, which will complete several assignments related to the Global Vision Team report. This also includes (1) asking Synod 2024 to encourage the classes (with the support of CRCNA agencies, institutions, and ethnic ministry networks) to develop their own connections to international churches and to periodically share challenges and opportunities related to this effort with the Office of General Secretary, and (2) asking synod to affirm the importance of this global vision so that adequate financial and human resources are put toward it.
- Adopted policies for the COD, including a process for COD election of officers, and how to handle objections about persons nominated as delegates to the COD.

- Provisionally approved several nominees to COD membership and recommended that Synod 2024 appoint them to these roles. Also assigned COD members to committees for the coming year.
- Endorsed a plan for the October COD meeting to include a board development presentation by Thrive staff on the One Family Conversation.
- Noted that the Bible Translations Committee is doing its work. A report on the Easy to Read Version will be ready in October.
- Heard from Greg Elzinga, interim president of Calvin University.
- Heard from Jul Medenblik, president of Calvin Theological Seminary.
- Received and passed along to Synod 2024 several “right of comment” documents regarding overtures to Synod 2024.
- Recommended that Synod 2024 celebrate six years of observance of the Day of Justice and recognize its continued expression in other venues rather than on an annual day.

Dear classes of the Christian Reformed Church:

Greetings in Christ's name.

Life with Christ requires us to embrace the divergent: dying to sin and rising with Christ, giving up our lives to receive them, and sowing seed in parched ground while trusting in harvest. The latter is the controlling image of Psalm 126, a psalm that encourages us to put down roots in the Lord despite being in very dry places. The psalmist pleads, *"Restore our fortunes, Lord, like streams in the Negev. Those who sow with tears will reap with songs of joy."* Today, many of our congregations are flourishing, and we see evidence of God sowing seeds all around us. At the same time, as a denomination we find ourselves face to face with a challenging and painful moment as some of our congregations consider disaffiliating. Even in this time of potential separation, we know that our God plants seeds and makes the desert bloom into joyful witness to his faithfulness.

I want to share a few notes regarding Synod 2024. First, please encourage your classis and its churches to carefully review the *Synod 2024 Frequently-Asked-Question* document posted at crcna.org/Synod2024FAQ. This document provides a helpful and factual guide to synod's deliberations in a time when there are many voices speaking about those decisions. Included in the FAQ introduction is a short video sharing a vision for the future of the CRCNA in light of these decisions.

Secondly, the Office of General Secretary will be sharing information with classis clerks about the impact of synodical disciplinary decisions on the CRCNA classes through letters and meetings this fall and winter. Thrive, the CRCNA's denominational ministry agency, and the Office of General Secretary, will also be making many resources available to support classes and congregations throughout the fall.

Thirdly and finally, I want to encourage all our classes to participate in the *Gather* initiative. *Gather* is a series of events in 2024 and 2025 intended to inspire, encourage and bring together CRC leaders from across North America. This is an intentional effort at renewal. At each event, five classes will come together to celebrate how God is moving in our communities and our churches. We'll pray and worship, share our stories and challenges, and discern where God is leading us in our mission. Each classis will be represented by 15 members and leaders from its churches.

Let's walk with God in gentleness and grace, and be prepared to be surprised along the way.

Update from Executive Director, Canada

Fall 2024

The CRC is in a tough spot. There is a sense of brokenness within our community. What I hear over and over again from a wide variety of people is how much *sadness* and *uncertainty* there is.

Sadness & Uncertainty

My kids were pretty young when we moved from Thunder Bay to Brantford, Ontario. They were really sad. Sure, they had some excitement about what was next, but they were grieving the loss of what they had.

Our temptation as parents was to try to cheer them up. But we decided instead to lean into the sadness together. We told our kids: it is *good* to be sad. It would actually be far worse if we were *happy* to be leaving. We were sad because of the deep relationships we had and the love we experienced. The house we lived in was comfortable and familiar and we would miss it. There were special events that we would no longer be part of after we moved. It was all quite sad *because it mattered*.

As a denomination, no matter what happens next, it will not be the same as it was before. My temptation, even now, is to try to cheer everyone up. But I believe it is ok to sit in the sadness, at least for a while. And this is true for all of us in the CRC.

Many of us are also uncertain about how decisions made at synod will affect our churches, councils, classis, and denominational ministries. There is uncertainty about how classis meetings will go this fall. Church Visitors and Regional Pastors are uncertain about expectations placed on them and how to walk with pastors well. I hear from pastors who are uncertain about what this means for effective pastoral care and how they will be perceived by their colleagues as they navigate the complexities of life with people.

I could go on. But I would like to note just how much powerlessness there can be in uncertainty. Many churches and pastors feel stuck in the uncertainty, and feel like this has all been forced onto them from the outside. Many are weary.

Ministry Together

In the midst of sadness, uncertainty, and weariness, I also find myself talking with many churches who are experiencing healthy, robust, and fresh opportunities for ministry in their local setting. Earlier this year, we hosted a "Stories and Strategies" meeting to share these experiences of ministry across Canada, and they were inspiring! We are also hosting a binational initiative called "Gather" that brings church leaders together to share how God is working in our congregations and communities, and wonder about how we could live into this in even stronger ways. We're also starting to gear up for the next Canadian National Gathering, where we can imagine and plan together as a national community.

My role is to ensure the denominational ministries are effectively supporting our churches. While I'd like to share all the different resources and opportunities, I often tell people I just want you to start with the assumption that the ministries can be helpful. No matter what you're facing, wondering about, struggling with, or finding success in: assume that there are good supports or partnership opportunities through your denominational ministries. People are often surprised at how much is available and how helpful it is. And when you share with us, we can share your experience with others allowing you to be part of the support other churches like yours receive.

Also, in the past few years, we've done a lot to strengthen and solidify our shared ministry in Canada. Your classis elects the members who sit on the Canadian Ministry board overseeing the ministry, and we have complete independence to discern and decide what ministry will best support churches and be a witness to our national community. My hope is that we can continue to work together to sustain and even increase the witness of our churches locally, nationally, and around the globe.

Renewal of All Things in Christ

I have been reflecting more and more on how all things are renewed in Christ. I do often wish he would hurry up and finish the job. But I believe that life is a journey of sanctification: every experience, every joy, every failure, every sadness, every uncertainty, every dying & rising with Christ is a contributor to our growing in Christlikeness. Sometimes we (and others around us) are not quite as far along our salvation journey as we would hope, and it often is measured in steps both forward and backward. But Christ is moving us toward the fullness of our salvation, this I am sure of. So we remain patient and tenacious as we seek the renewal of all things together.

As we continue this path, my commitment is to ensure that our shared ministries are there to support you in your local ministry and in what we can do regionally, nationally, and around the world. I'm grateful for all the ways you all continue to welcome us into this journey with you.

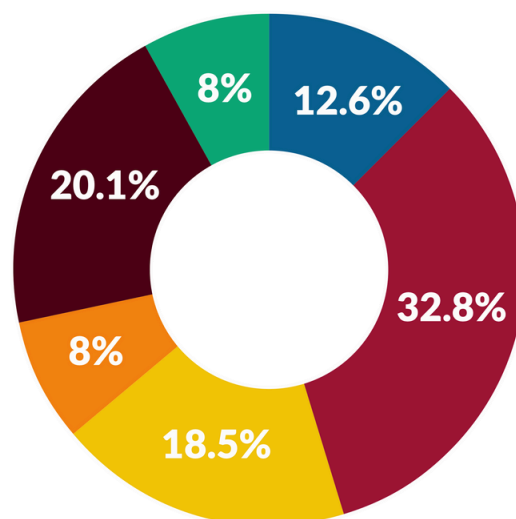

For managing these financial gains, my top recommendation is the Canadian National Christian Foundation (CNCF).

Here's why:

- CNCF lets you manage your assets efficiently while shifting them off your books, ensuring compliance and clarity.
- Customize your fund without yearly spending rules.
- 100% of your CNCF Giving Fund is ready for charity grants—no minimums or maximums, allowing you to direct funds to charities, including your own church.
- CNCF can work with your church's financial professional to manage the assets in your CNCF Giving Fund, if desired.
- CNCF functions similarly to a foundation, providing churches under its umbrella the capability to manage larger holdings. Benefits include the ability to hold and invest funds, recommend grants, and handle complex gifts such as public securities and legacy gifts.



If you're keen to dive deeper into this option, Ray Borg at CNCF (ray@cncf.ca) is my vetted recommendation for your church. He comes highly recommended for his expertise in helping churches like yours manage funds effectively.

Helping Your Church Receive Legacy Gifts

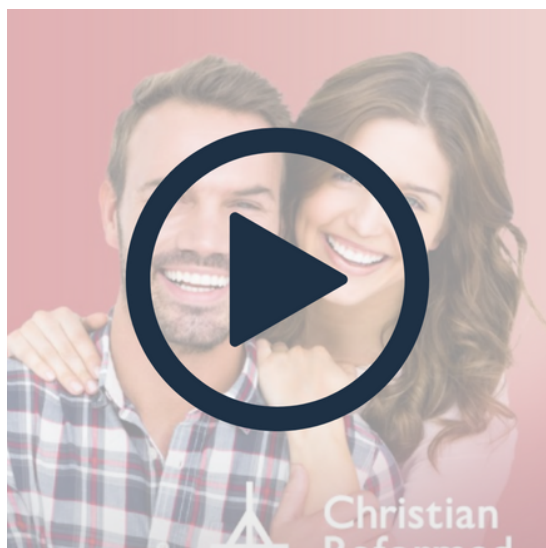

ONCA Reminder

A friendly reminder for our Churches in Ontario that you are a registered nonprofit under Ontario's Corporations Act, then Ontario's Not-for-Profit Corporations Act (ONCA) is applicable to you. This includes both churches and Ontario classes.

ONCA became law on October 19, 2021. Existing not-for-profit corporations and registered charities have until October 18, 2024, to ensure their compliance with ONCA.



- **ONCA Webinar:** In July 2023, the denomination conducted a comprehensive presentation on Ontario's not-for-profit corporations act.
- **Legal Support:** If you require legal support and guidance related to ONCA compliance, Community Legal Education Ontario (CLEO) has compiled a list of lawyers who are available to assist in this matter. The list includes several lawyers (Teresa Douma, David van der Woerd, Terrance Carter) who have worked within our denomination and have extensive experience in assisting churches and nonprofits, particularly with ONCA matters.

Fall Classis Report



Greetings Deacons & Churches!

For our report this fall, we thought we would answer some of the **Frequently Asked Questions** we get!

Perhaps you've even asked one (or three) of these!

#1 - How did Diaconal Ministries Canada get started?

We get this question a lot! Believe it or not, [our roots](#) go back to the 1950s! Across Canada, deacons were longing to gather to learn together and share ideas and best practices. They knew that ministry was always better when done together! This resulted in local and regional "conferences" being formed. In these early years, World Renew (CRWRC at this time) worked closely with diaconates on both sides of the border as they pursued ministries of justice and mercy, both locally and globally.

Over the years, these diaconal conferences expanded and contracted. It was during this time that Canadian deacons began to wonder what it would look like to have a national organization oversee the training and equipping of deacons. Finally, in 1998, at a Classis Renewal Gathering in Chicago, various deacons, along with reps from Home Missions (now Resonate Global Mission) and CRWRC, met over lunch and began sketching out their ideas on napkins (the only paper they had available!!).

It was an exciting time and, after a few more years of discussions (and maybe some more napkin drawings), the boards of the existing diaconal conferences jointly approved the formation of a new organization. In 2001, Diaconal Ministries Canada was officially constituted!



#2 - How is Diaconal Ministries funded?

When Diaconal Ministries Canada was born, it adopted the ministry share model that was part of an agreement that Canadian deacons made with each other in the 1960s and recommitted to in 2001.

It's important to note that these are different from *Denominational* and *Classis* Ministry Shares. **We do not receive any funding from the CRCNA, like our friends at Resonate or Reframe.**

Each August we send Ministry Share invoices to churches based on a per member rate. We ask churches to give as they have been blessed so that ALL churches in Canada can receive our resources and support. We also rely on extra offerings and donations. 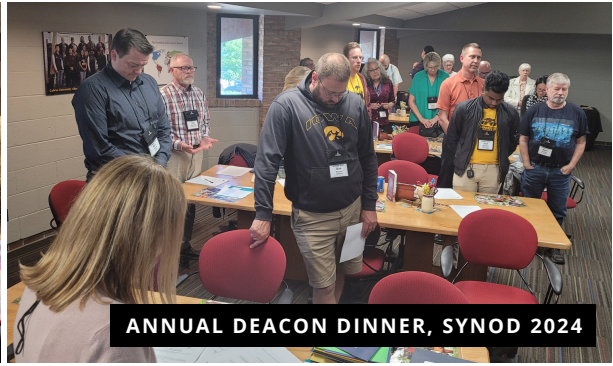
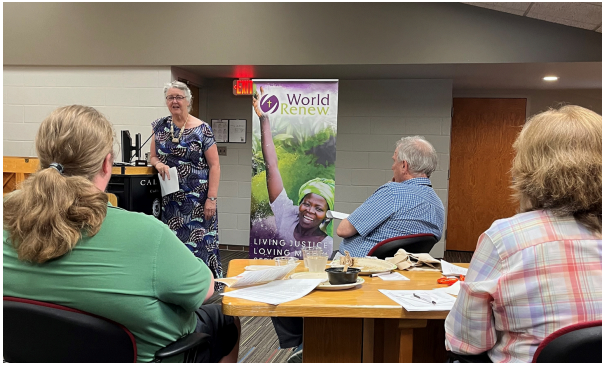
#3 - How does Diaconal Ministries support deacons?

Our ultimate aim is to equip and encourage deacons in the areas of *community engagement, service & justice, benevolence, and stewardship*. These focus areas come straight out of the [Deacon's Mandate](#) (the charge read to deacons when they are installed). On top of this, we help with leadership development.

We do this through our [field staff](#) (two Regional Ministry Developers - one in Western Canada, one in Eastern) and our amazing team of [Diaconal Coaches](#), approximately one per classis.

We offer relevant workshops and trainings where deacons walk away with practical tools and resources they can use to live out their calling, both in their church and in their local community.





#4 - Does Diaconal Ministries Canada work in the USA as well?

We are a unique and distinct Canadian agency, created *by* deacons, *for* deacons. To date, we have no counterpart in the USA. Most diaconates there rely on a regional diaconal conference or will often turn to World Renew US for help and guidance. *Don't you feel spoiled?*

Having said that, we look for opportunities to partner with other CRCNA ministries any chance we get! One way we collaborate with World Renew US is for the annual Deacon's Dinner held at Synod. Also, this past year, Thrive began beta testing a "Deacon Essentials" course - primarily for US deacons who don't have access to an agency like ours. We were happy to contribute input on this course and hope it is a blessing to those who take it!

#5 - What happened to Operation Manna?

When the Operation Manna Program became an official program of Diaconal Ministries Canada in 2001, its primary purpose was to *"engage Christian Reformed Churches in community ministries that seek to bring about sustainable change in individuals and communities experiencing significant needs."* Because of this, many of our early [Operation Manna partners](#) are still growing and thriving today!

While we celebrated the meaningful impact Operation Manna had on churches and communities across Canada for several years, the conversation surrounding changing the name and updating the program's activities started over ten years ago!

On March 1st, 2019, the Operation Manna Program became NewGround.

NewGround continues to empower deacons and churches - offering coaching and resources to help them break new missional ground, nurturing Spirit-led ideas that bear everlasting fruit! Find out more [HERE](#).





NewGround - Impact Story

How one man's life was changed by an after-school program in Brockville

[Cross Town Impact](#) (CTi) is an after-school program for vulnerable youth in Brockville, ON. They provide a safe and inclusive space that provides a positive, encouraging environment for youth and lets them know they are loved, especially by God. This NewGround partner is supported by Athens CRC (Athens, ON).

Greg Houldcroft is the founder and director of CTi. Recently, Greg was at Kemptville CRC to share about this ministry. Everyone there was encouraged by CTi's work in the local public schools in Brockville and how it is impacting that community.

While Greg was in Kemptville for the day, he went to McDonald's. There, he spotted a familiar face—one of the youths from his group from over 20 years ago, named Peter*. Peter was there with his three boys - ages 2, 5, and 7. Greg and Peter shared a meal together, and then he invited Greg back to his home for coffee.

During their conversation, Greg discovered that this former youth was now a pastor in Kemptville!

Greg shared that their visit was nothing short of marvelous. "As we reminisced, Peter became emotional and shared how much my investment in him through mission trips, both local and national, and youth trips still impacts him today. He told me that the genuine love I showed him continues to encourage him to this day. It felt like hearing a beautiful eulogy, but instead of being delivered at a funeral, it was a heartfelt, face-to-face conversation. Needless to say, it was a very good day."

This is the impact NewGround and its partners are having in communities across Canada!

CLASSIS REPORT: Fall 2024

1. In early August a ship arrived with all Bangladeshi crew. When I boarded the ship, it was quickly obvious that the crew was feeling low. Many shared at length about the difficult situation in Bangladesh, including protests and riots against the Prime Minister. One seafarer reflected that though he was bodily on the ship, his mind and soul were very much back in Bangladesh, full of concern for his family. The crew were not allowed shore leave because so many Bangladeshi seafarers have recently jumped ship to escape the despair back home. "Something will happen very soon in Bangladesh," I was told.

A few days later news of massive protests and the fleeing of the Prime Minister was reported. A few days later, back on board again, the mood had been transformed; all were excited about the recent events and filled with new hope. It was fun to celebrate with them. Many shared how much they appreciated the support of the seafarers' centre. Two of the crew requested audio Bibles, as they wanted to more about Bible and who Jesus is – very exciting news among an all-Muslim crew!

2. At the end of June I completed the final month of my 3-month sabbatical. In February-March my wife, Jennifer, and I spent nearly 2 months in Asia (mainly Malaysia) reconnecting with many friends, churches, and the 2 seminaries there where we served previously. It was very good to be back again. In June we were in Europe, part of the time in Greece on a "Footsteps of Paul" tour. Thanks to the board for provision of this time.

3. One highlight of my sabbatical time, related to this ministry, was my visit to the Port of Singapore to meet with some of the chaplains there. Compared to our Vancouver port's approximate 3,000 vessel visits per year, Singapore receives about 140,000 vessels per year!! The chaplains told me they only visit about 2% of the vessels that come. Obviously a very different situation, yet the focus of ministry is still similar.

4. In mid-July we bid farewell to Ashu Biswal, who served so capably since January of this year as intern and helped to cover in the work here especially during my sabbatical.

Ashu has accepted a call to serve as associate pastor at Richmond Pentecostal Church. We thank him for his service and wish him all the best. Ashu's time with this Ministry is another good example of God's provision – he came along at just the right time and was able to serve with us for just right amount of time. Praise the Lord; He is faithful!

5. This summer we have been filming for a new Ministry to Seafarers' video. I plan to show it at Classis, and it will be accessible on the website and through our YouTube channel. We'll also be producing a related short video focusing more on the history of this Ministry, especially appropriate as we approach our 55th year of ministry in 2025.

6. Carlos worked on one of the cruise ships that visited Vancouver this summer. He began feeling ill during the summer and eventually needed to be hospitalized. It turned out he has TB. He needed surgery to drain fluid from around his lungs and spent nearly 4 weeks in the hospital. We were contacted by his company, and I visited him several times. He happily received a Bible and devotional materials and was always ready to be prayed for. The illness led him toward a renewal of his faith, and it was a real joy and privilege to walk with him on this journey.

His final week in Vancouver was spent in a downtown hotel. The day before he flew home I took him out for a delicious Filipino lunch. Kudos too to the cruise ship company, who cared for him well through this experience. They even flew him home business class!



7. 2025 will mark 55 years of Ministry to Seafarers serving here in the Port of Vancouver. The board hasn't yet discussed plans, but it would be appropriate to organize an event or two to celebrate, especially since our 50th anniversary plans were cancelled due to Covid. Options could be:

- a large celebration gathering, possibly at New Westminster CRC?
- another port tour cruise?
- other suggestions?

We will update you on board discussions at classis.

8. Finally, a note that we are still in need of a couple more board members. We especially need another member from Classis BCNW.

Report to Classis Alberta South/Saskatchewan of the Christian Reformed Church: Fall 2024

Greetings from The King's University! As we begin to celebrate our 45th anniversary, we are excited about the upcoming 2024-2025 academic year and are thankful for the increase we are seeing in the size of our incoming student cohort compared to last year. At this point in the student registration process we are on pace for a 3%+ increase in our student headcount from last year. We thank God for His continued provision of students who are eager to engage in Christian university education at King's.

Construction plans for the creation of our new Centre for Excellence in the Sciences are well underway with detailed designs currently being developed. A portion of the original campus containing primarily administrative and faculty offices will be demolished and the new three-story centre will be constructed in its place. Demolition of the old infrastructure is already underway and displaced staff and faculty have been temporarily relocated to other areas of campus. Construction of the new facility is slated to begin this fall and we are anticipating the completion of the project by September 2026. The Centre for Excellence in the Sciences will include space for a student coffee shop, research labs, additional teaching spaces and faculty and administrative offices. This new building will provide space for us to continue to expand programming in the sciences and will support continued enrolment growth. The building has been fully funded through charitable gifts from our community and we are continuing to raise support for program expansion, student scholarships, research funds, and ongoing operational costs. To date, over \$24M has been donated to make this strategic vision a reality. We are so thankful for the community of supporters who continue to support the Christian university education that King's provides.

The King's University has exciting news for students passionate about psychology and the natural sciences. Starting this fall, King's psychology offerings will expand into the human health sciences with the launch of a new Bachelor of Science in Psychology. The current Bachelor of Arts (BA) in Psychology emphasizes a social sciences perspective. The BSc program will attract students who are more interested in the physiological aspects of human brain and behaviour. Dr. Heather Looy, Professor of Psychology at King's, says the new undergraduate program will add more depth to the biological side of the field of psychology. "The program will include advanced biology-based courses such as human anatomy, human physiology, neuroscience, and psychopharmacology. These courses provide psychology students with a greater understanding of human health and prepare them for more clinical and research-oriented careers."

Thanks to generous gifts from our support community, King's is launching a new Sustainability Innovation and Research Hub. Our vision is to become a leader in sustainability transition innovation and research that is guided by our Christian understanding of humanity's God-given responsibility to steward His creation. The innovation and research hub (to be housed in the Centre for Excellence in the Sciences) will catalyze internal research and action projects at King's related to sustainability transition, become a regional hub for sustainability transitions research, and foster sustainability action, in partnership with local, national, and international academic and non-academic institutions (faith-based organizations, church networks, NGOs, etc.).

Research Spotlight: Dr. Caroline Lieffer, Associate Professor of History, had an article published in the July/August issue of *Faith Today*. The article, entitled "Faith Sustains Workers Amid Unjust Conditions," explores the importance of faith, community, and hope during the dangerous and dehumanizing conditions of the Panama Canal's construction.
